I asked Steve Stewart to look into this topic. Below is his response and where we are with documents at this time. See attached.

Rick:

I got on the Illinois Secretary of State website and found three (3) corporations in good standing:

- 55239371 Walk In The Word Ministries NFP incorporated 9/28/88 Chris Nudo, Agent 1250 Larkin, Suite 100 This is part of HBC.
- 59798804 Walk In The Word NFP incorporated 2/10/98 Chris Nudo, Agent 1000 N. Randall Road This is the one with the \$100k CD.
- 72239709 Walk In The Word with Dr James MacDonald NFP incorporated 3/13/19 Incorp Services, Agent 901 S. 2<sup>nd</sup> St, Suite 201, Springfield, IL 62704

And on the 72239709 corporation, Tom Winters set this up and named Nudo as the Agent. Then Winters changed the agent to Incorp on 5/9/19.the Agent information appears to have been changed as of 5/9/19.

Pastor James does not need our WITW NFP because he has set up a new one 72239709. But the \$100k CD is still in the one we control 59798804.

The Annual Report for 59798804 was filed 3/29/19, showed Chris Nudo as the Agent, and listed Sperling treasurer, vacant president & secretary, and directors Booras, DeLasAlas, Desmaris, Dierker, Kuntz, and Jeff Smith. It has not been updated since the elder board changed. It is not required to be updated, but we could update it if we wanted to.

I can find no minutes of 59798804 ever meeting as required by the attached filed By-Laws.
